Subject: Call for Proposals for the EUROTOX 2025 Congress Scientific Program

GENERAL GUIDELINES FOR SCIENTIFIC PROPOSALS

- Submit your scientific proposals using the official template making sure to include the organiser details, the recommended speakers, and a brief presentation for the proposal.
- Proposals will be evaluated based on the following criteria: scientific quality, relevance, timeliness and completeness of the information (including details of all speakers, chairs, title, and short description).
- Geographical distribution (not more than 2 speakers from the same country, except for CEC's)
- Session organisers should make every effort to include speakers from Academia-Industry-Regulators, and interdisciplinary approaches (basic research, clinical/epidemiological, regulation).
- Sessions should include a Chair and a Co-Chair.

SPECIFIC GUIDELINES FOR SCIENTIFIC PROPOSALS

SYMPOSIA

Aims to be topical or cutting-edge scientific knowledge exchange with experts in the area presenting data from their research and answering questions from the audience.

90-MINUTE SYMPOSIA

- Should last a total of 90 minutes and have a maximum of 3 speakers.
- The first speaker should set the scene for the symposium by explaining briefly the background to the topic before presenting his/her data.
- Presentations should be 25 minutes with 5 minutes for questions for a total of 30 minutes per speaker.

120-MINUTE, TRADITIONAL SYMPOSIA

- Should last a total of 120 minutes and have a maximum of 4 speakers.
- The first speaker should set the scene for the symposium by explaining briefly the background to the topic before presenting his/her data.
- Presentations should be 25 minutes with 5 minutes for questions for a total of 30 minutes per speaker.

WORKSHOP

Aims to review a specific topic or area, providing state of the art opinions or presenting a controversial viewpoint, with a panel discussion as well as questions and answers being an integral part of the workshop.

- Should last a total of 90 minutes and have a maximum of 3 speakers (25 minutes per speaker)
- Selected area of interest can include methods or technology topics.
- The last 15 minutes should be allocated to Q & A in the form of a panel discussion involving all speakers.
- The Chair should introduce the topic and set the scene for the talks and discussion.

ROUNDTABLE

A discussion-based session of 120 minutes with 4 participants. Only short presentations should be planned (5-10 minutes each presenter) with the majority of time allocated for open discussion with the panel and the audience.

CONTINUING EDUCATION COURSE (CEC)

An educational session with 4-6 experts in the field presenting a balanced view of established principles. Proposers/Chairs should ensure they work with individual speakers to achieve balance and prevent topic overlap. Scheduled Sunday from 9:00 am to 4:00 pm, including coffee and lunch breaks. We are accepting proposals with topics other than (1) Exposure Assessment (Epidemiological aspects, and Exposome developments) and (2) Neurotoxicology (Neurobehavioral aspects, and In vitro models) which will be organised by EUROTOX.

KEYNOTE LECTURE

One speaker, lasting a total of 45 minutes. Proposals should feature international renowned leaders in the field, and presenting recent hot topics or an authoritative overview of issues of broad interest.
